1. Analysis of the results:

- Total Polling Stations Reported **19** out of **19**
 - **18** polling Station results were entered into the result database , which represents **94.74%** of all the polling stations in the Ward.
 - The total number of votes cast is **4390**
 - Percentage voter turnout was **83.18%**
 - There were **4216** valid votes
 - There were **174** invalid votes, which represents **3.96%** of votes cast
2. Now therefore, as Regional Returning Officer, for the **Eastern Region**, I hereby announce the results obtained by each candidate in Ward **92**.
